Shirika la Uvuvi Tanzania (TAFICO) ni Shirika la umma linalomilikiwa na Serikali ya Tanzania chini ya Wizara ya Mifugo na Uvuvi. TAFICO ilianzishwa mwaka 1974 chini ya Sheria ya Mashirika ya Umma Na. 17 ya mwaka 1969. Shirika liliendesha shughuli zake kwa ufanisi mpaka mwaka 1996 ambapo liliwekwa kwenye Orodha ya Mashirika ya Umma yaliyotakiwa kubinafsishwa chini ya Tume ya Rais ya kurekebisha Mashirika ya Umma “Presidential Sector Reform Commission (PSRC)”, hata hivyo, serikali haikufanikiwa kulibinafsisha na mwaka 2015 iliagiza Shirika liendelezwa. Mwaka 2018, Wizara ya Mifugo na Uvuvi ilianza mchakato wa kuliendeleza ambapo mwaka 2022 Shirika lilianza utekelzaji wa majukumu yake kwa mujibu yake kwa mujibu wa muundo.

**INTRODUCTION**

Tanzania Fisheries Corporation (TAFICO) is a public corporation owned by the Government of Tanzania under the Ministry of Livestock and Fisheries. TAFICO was established in 1974 under the Public Corporations Act No. 17 of 1969. The organization operated effectively until 1996 when it was placed on the list of Public Organizations to be privatized under the ‘Presidential Commission for the Reform of Public Organizations (PSRC), however, the government however, the government failed to privatise it and in 2015 ordered the Corporation to be developed. In 2018, the Ministry of Livestock and Fisheries began the process of developing it, and in 2022 the Corporation began the implementation of its duties according to the structure.

To be a competitive organization in commercial fisheries and aquaculture in sub-Saharan Africa.

To play an important role in the development of the fishing industry in Tanzania through the fishing of the deep seas and territorial waters, aquaculture and adding value for sustainable social and economic development.
